Mission, Vision & Values

Who We Are

Four Mothers Collective is a community-based arts organization led by Indigenous women in Tulsa, located on Mvskoke Nation.

We support Indigenous artists through exhibitions, workshops, mentorship, cultural education, and community-centered gatherings.

Our focus is on connection, to one another, to land, and to the long line of knowledge we carry.

Our Values

- Cultural Sovereignty – We create from our own stories, standards, and teachings.
- Reciprocal Care – We prioritize community wellbeing and mutual support.
- Access + Representation – Indigenous artists deserve visible, dignified space to create and be seen.
- Intergenerational Learning – We learn from our elders, teachers, peers, and youth.

Year in Review: Highlights

Exhibitions

Our annual exhibition this year, *From the Heart: Expressions of Indigenous Joy*, was held at Positive Space Gallery in Tulsa, Oklahoma. Co-curated by Jessi Sands and Carly Treece, the exhibition featured 23 artists representing 18 Tribal Nations, celebrating Indigenous joy, resilience, and creative expression. In conjunction with the exhibition, Four Mothers Collective hosted its first gallery market, a ceramics workshop, and an artist talk, expanding opportunities for artists to engage directly with community.

Building on this momentum, our 2024 exhibition, *Ripple in Traditions*, was invited to become a nationally traveling exhibition in 2026, with two locations secured: the Mid-America All-Indian Museum and the IAIA Museum of Contemporary Native Arts. This milestone reflects the growing recognition of Indigenous women-led curatorial work and the strength of Four Mothers Collective's community-centered model.

Year in Review: Highlights

Workshops & Programs

In April, Four Mothers Collective opened our dedicated community space, expanding our capacity to host consistent, accessible programming rooted in relationship and care. Throughout the year, we hosted 9 artist-led workshops, directly supporting and compensating 9 Indigenous artists, along with 28 open studios, an artisan gallery market, an artist talk, a community meal, several film club gatherings, and a Free Little Indigenous Library, increasing access to Indigenous literature and learning resources.

We also supported broader community care efforts by assisting our neighbor Southwest Trading Company with their community food pantry. Together, these programs reflect our commitment to creative sustainability, accessibility, and meeting community needs through art, education, and mutual aid.



Year in Review: Highlights

Partnerships & Community Collaborations

Collaboration remains central to our work. This year, we partnered with Words of the People to host monthly rematriation writing workshops, and with the Oklahoma Birth Equity Initiative for a special event honoring Indigenous Milk Medicine Week. We also supported the Tulsa Indian Club through their princess fundraiser and collaborated with New York University to expand dialogue beyond our local community.

Additionally, we teamed with the Muscogee Nation's Native Youth Community Project to support youth-focused programming and intergenerational knowledge-sharing. These partnerships deepen our impact and reflect our commitment to building through trust, reciprocity, and shared values.



Impact by the Numbers

Four Mothers Collective supported Indigenous women and Two-Spirit artists through exhibitions, education, and community-centered programming throughout the year.

Artists Supported

- 22 artists in the annual exhibition
- 6 artists in the artisan gallery market
- 3 artists featured in an artist talk
- 1 curator supported in a paid curatorial role
- 3 artists supported through framing and exhibition preparation
- 3 artists supported through professional artist bio development
- 9 artist-educators leading workshops
- 21 youth artists engaged through programming

Total Artists Supported: 272

Programs & Participation

- 12 workshops hosted (9 hosted on site, 3 off site)
- 28 open studio days

495 artists and community members served through use of space, including open studios, workshops, partner events, and the annual exhibition.

Geographic Reach

- Artists and visitors from across Oklahoma, with additional visitors from California, South Dakota, Tennessee, Iowa, and other regions.

Artist Compensation

- All workshops, curatorial roles, and artist talks were artist-led and compensated, reflecting our commitment to ethical pay and sustainable creative practice.

Impact by Numbers

Funding Overview

- 97% of organizational funding was provided through foundation and institutional grants
- 3% was supported through community donations and fundraising efforts

Use of Funds

During this first year of expanded operations, funds were intentionally allocated to:

- Opening and activating a dedicated community space
- Compensating artists, educators, and cultural workers
- Supporting workshops, exhibitions, and community programs
- Building essential organizational infrastructure to support long-term sustainability

I hope people take away that joy comes in many forms and to foster it in their daily lives, communities, and how they engage in the world

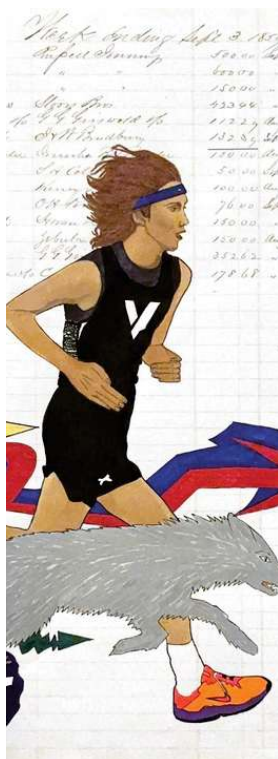

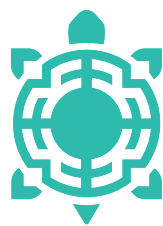

As Four Mothers Collective moves forward, we remain committed to centering Indigenous women and Two-Spirit artists while strengthening the infrastructure needed to sustain this work long-term. In the coming year, our focus is on deepening impact through thoughtful growth, continued collaboration, and care-centered programming.

Key priorities ahead include the expansion of our traveling exhibition, with confirmed institutional partners and additional venues in conversation; continued use and activation of our community space for workshops, open studios, and gatherings; and increased support for artist educators and youth artists through accessible, paid opportunities. We are also working toward greater financial sustainability through diversified funding, partnerships, and earned income strategies that align with our values.

Looking ahead, Four Mothers Collective will continue to build slowly and intentionally, grounded in ancestral knowledge, responsive to community needs, and guided by the belief that art is both a cultural practice and a form of care.
